## BUDGET CUTS – The Good, The Bad and the Ugly by Deborah Cima

Like many counties, San Bernardino County relies heavily on the DCP, CDCI and Dependency CDCI grants to support their 9 adult drug courts and two dependency drug courts. The total amount cut from the San Bernardino drug court programs was \$227,000.00. That included the match requirements from the grants. In order to sustain operations in the courts we had to look closely at many factors, including such things as client fee revenue collection, drug Medi-Cal billing, and treatment resources in the community and client capacity. After many long exhausting meetings with our partners it was concluded that we would reduce the numbers of clients in our largest drug court by 55 participants (from 167 to 112), reduce the number of days in treatment from 5 days a week to three, and become much more flexible on length of time in treatment. That is, we used to have a 12 month-long treatment protocol, no matter how well somebody progressed in the program. We added flexibility to the length of phases and now, if someone has six months sobriety, meets their treatment goals and has a full time schedule of employment and or school, we will let them graduate earlier than before. This will allow us to open up more treatment slots and will help motivate participants to complete their treatment goals sooner. We also had to change providers in one of our programs in the high desert. Although there are less intensive treatment protocols, the number of drug tests and court appearances stay the same. It is a hybrid drug court and we are looking forward to the evaluation of these changes. These changes did not come easy and many opposed the treatment protocol changes. (cont page 4)

<p><b>California Drug Court Cost Analysis Project:</b> An Opportunity for Program Self-Evaluation</p> <p>by Jane E. Carey, NPC Research Mark Waller, NPC Research</p> <p>In 2000, the Judicial Council of California initiated a comprehensive study to examine the costs and benefits of its drug court programs and to identify cost-effective practices for such courts throughout the state. Adjudicating offenders through the nine drug courts chosen for the first phases of the study resulted in significant savings for the California criminal justice system.</p> <p>While other studies have shown that drug courts reduced drug use and criminal behavior, few of them have examined financial costs and benefits on a statewide level, until now. On launching this study, the Judicial Council recognized the need to compile definitive information about the fiscal impact of these innovative programs, so that courts can make better informed policy decisions.</p> <p>The <i>outcome</i> cost-benefit analysis focused on recidivism, including re-arrests, new court cases, jail/prison/probation time served, and victimization costs arising from property crimes or crimes against the person over a four year period.</p> <ul style="list-style-type: none"> <li>• Outcome benefits (savings) varied widely among sites, ranging from about \$3,200 to <i>over \$15,000 saved per participant.</i></li> <li>• Average savings from positive outcomes (including savings due to less victimization) = \$11,000 per participant.</li> </ul> <p>PRESIDENT’S MESSAGE (cont from page 1) One important group of sessions at the Conference relates to existing and new</p>	<p>Additionally, drug court participants had low recidivism rates. As a part of this statewide launch, a web-based tool was created by NPC Research in collaboration with the AOC. This tool, called the Drug Court Cost Self-Evaluation Tool (DC-CSET), can be used by drug courts statewide to help determine their own costs</p> <p>The tool is designed to allow each drug court in the state to gather information to evaluate drug court program costs and benefits. Results from the study can be used to advocate for local, state and federal funding and to identify cost effective court practices. The DC-CSET can help answer questions such as:</p> <ol style="list-style-type: none"> <li>1. What are the total criminal justice system costs invested in drug court?</li> <li>2. What are the costs for each agency that invests in drug court?</li> <li>3. What are the cost-benefits associated with drug court?</li> <li>4. What are the benefits for each agency?</li> <li>5. Which expenditures provide taxpayers with the best return on their money?</li> </ol>	<p>This web-based tool will assist local courts in evaluation efforts and will provide a standardized method of gathering information.</p> <p><i>To date, the Administrative Office of the Courts has trained over 19 adult drug court programs and would like to provide training and technical assistance to additional courts to complete this tool.</i></p> <p>Technical assistance will be available through NPC Research as programs begin implementing the tool. Upon completion a cost report will be provided to each court. funding opportunities through Federal grants. At a time when we face a dire fiscal crisis in California, we must be competitive and take advantage of every opportunity to secure new funding.

For example, the JAG/Byrne program that had no support from the previous Administration and suffered severe cut-backs has been restored. Funding will be available in the coming months and Drug Courts are eligible to compete for this funding. Decisions are made locally, and every drug court and collaborative court practitioner needs to know the new application process and the importance of forming local alliances with law enforcement.

Laurie Robinson, Acting Director of the Office of Justice Programs, states that the Department of Justice "is operating 24/7" to move Recovery Act stimulus dollars into the hands of state and local programs. The Stimulus will be followed by the 2009 budget (yet to be passed), which will quickly be followed by the 2010 budget. The House has already voted a substantial increase in funding for drug courts through the DOJ as well as CSAT in SAMHSA.

The entire area of reentry courts is now opening up. At the State level here in California, Senator Denise Moreno Ducheny, Chair of the Senate Budget Committee, has introduced legislation to create pilot reentry courts for parolees with substance abuse and mental health issues, following the drug court model, and placing Jurisdiction in the Courts rather than the Board of Parole Hearings.

These are only a few of the opportunities I see for the continued growth and sustainability of drug and collaborative courts. However, although our State Funding remains the same in the present budget, we must aggressively pursue every opportunity that is afforded us to continue to build the drug court and collaborative court system in California. I hope you will

attend this important conference to re-energize our movement and commitment through networking with other professionals who share our vision.

Please note that if your County will not permit the use of local funding for Conferences and Travel, there is funding available to make it possible for you to attend. Please review the special article in this Newsletter about that funding source.

Finally, I urge you to either join or renew your membership in CADCP. I realize these are difficult financial times for everyone. However, unlike many organizations, the funds we receive are used to support educational and training conferences as our major goal. That is why each year we are able to offer a training conference at a very reasonable cost in comparison to others. The cost of membership remains at only \$25/year. Our training conferences do not produce revenue for the association. Rather, our funds support making training and education available at the lowest cost and for the greatest number of professionals possible. Your annual dues help make this possible. Please be a paying member of this organization. I look forward to seeing you in Anaheim this June!

However, after reviewing the AOC monograph titled California Drug Courts: A Methodology for Determining Costs and Benefits, we realized we were implementing many of the Promising Practices described in this very informative report.<sup>2</sup>

San Bernardino participated in the cost analysis research project through the AOC and NPC Research and found it to be very beneficial. The report told us that not only are we saving the county in jail-beds days, but every department involved with drug court is experiencing cost savings. For instance, average cost/traditional court offender to the court is \$1,686. Average cost/drug court participant is \$1,299 for a cost savings/ participant of \$387.00. San Bernardino has an average of 500 participants going through the program at any given time. This is a savings to the court of \$193,500!

The average cost/ traditional court offender for the Public Defender's officer is \$686, for a drug court participant the average cost/drug court participant is \$202 for a savings of \$479.00/ participant. With 500 participants in program, the savings to the Public Defenders office is \$239,500.00. The cost analysis data base is user friendly and the NOC researchers are available to help you through the process. I encourage all courts/ coordinators to get their court evaluated.

### Choice of Drug Czar Indicates Focus on Treatment, Not Jail

The White House said yesterday that it will push for treatment, rather than incarceration, of people arrested for drug-related crimes as it announced the nomination of Seattle Police Chief R. Gil Kerlikowske to oversee the nation's effort to control illegal drugs.

The choice of drug czar and the emphasis on alternative drug courts, announced by Vice President Biden, signal a sharp departure from Bush administration policies, gravitating away from cutting the supply of illicit drugs from foreign countries and toward curbing drug use in communities across the United States.

In promoting wider use of drug courts, the administration is embracing an idea that has broad support in theory but has never been a main path for people with drug addictions who are charged with crimes.

The Obama administration has not said how much money it wants to devote to the courts' expansion.
